

TERMS & CONDITIONS

The consumer promotion contest, "Get a chance to Meet Shah Rukh Khan" ("Promotion") is sponsored by Western Digital UK Limited ("Sponsor") and administered by TLG India Pvt. Ltd. ("Administrator"). Participation in the Promotion constitutes an entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Participating in the Promotion is voluntary and all products from the outlets will be available without participation in the Promotion.
